Communication

In an effort to more effectively communicate with parents and students, we will be encouraging everyone to use the Jr. High section of the Nixa bands website: www.nixabands.org. From the website you will be able to print out your weekly band journal forms as well as view or print out other important, band related information.

I. Objectives

The Nixa Jr. High band program consists of two bands, a 7th grade band and an 8th grade band. The objectives of the band program are as follows:

- A. To develop musicianship and musical technique through expressive experiences with various styles of music.
- B. To develop an appreciation for the arts.
- C. To develop responsibility as a band, school, and community leader.
- D. To represent the school as an instrumental music ensemble at music and community events.
- E. To develop individual and group concentration and discipline.

The band program emphasizes self-discipline, responsibility, communication, and commitment. It is believed that these are the life skills every student can take from the band experience and apply toward real world situations. The directors will work very hard to instill these values into every student so that we can establish a program that is based strongly upon dedication to the group, and not just individual grades or experiences.

II. Attendance

- A. **Rehearsals:** Attendance at all scheduled rehearsals is required unless excused by the directors.
- B. **Performances:** Attendance at all scheduled performances is required unless excused by the directors. These will include all parades and concerts.
- C. **Excused absences:**
 - *Personal illness
 - *Death in the family
 - *Other **school** functions (please give notice of the conflict as soon as possible so the directors and other activity sponsor(s) can try to work out a reasonable solution.)
 - *Other conflicts will be considered on an individual basis.

III. Grading Scale

The grading scale is divided up into four categories: *Band Journals, Scales, Participation and Performance*. Each category is weighted to represent 25% of the grade. Grading within each category is as follows:

& Extra Effort

- A. **Band Journals:** In an attempt to support reading and writing across the curriculum as well as provide a systematic practicing process, all students will have a weekly writing assignment. Band journals will be turned in at the first rehearsal of each week. Students should have one for every day of class during a week. If it is a 5 day week = 5 required, 4 day week = 4 required, etc... Journals are worth a total of 25 points per week, receiving 5 points for each daily entry. Journals will be given full credit if turned in by the due date.

All students are expected to complete a minimum of 7 band journals per quarter. The directors reserve the right to ask anyone not meeting this requirement to drop band

Should a student be absent from class on the day practice journals are due, it is the responsibility of the student to remember to turn the assignment in on the day they return.

Band journals are homework. Just because a student may have activities the night that they are to practice, the assignment is still due. Parents are encouraged to be a positive part of this process. If you don't hear your child practicing, they're probably not practicing. Have your child play the assignment for you before signing off on their practice journal. A parent signature is required for credit on the assignment.

- B. **Tests:** Playing tests will be given. Each test will be assigned a certain number of points based on the material.
- C. **Participation:** Participation credit will be given daily to all students and be tabulated weekly. Students may earn up to 15 points daily – 5 points for being on time, 5 points for being ready to play and 5 points for being on task. Students wishing to receive full credit for participation must adhere to the following guidelines:

BE ON TIME: When the bell rings, students will have one minute to be their seat ready to begin their bell work. If a student is not seated and ready to begin bell work one minute after the bell they are not on time and will be marked tardy in the school's attendance system.

BE ON TASK & READY TO PLAY: To be ready to play, a student must have their instrument, music and pencil with them throughout the rehearsal and demonstrate proper rehearsal etiquette.

- D. **Performances:** Performances are one of the main assessment tools used for this class. Attendance at all scheduled performances is required unless excused by the directors. Students are expected to dress in appropriate concert dress attire. (No jeans, no tennis shoes). There may be times when additional concerts or performances are scheduled. When this occurs, parents and students will be notified as soon as possible. Students that do not attend a scheduled performance will not receive credit for that performance. Each performance is worth 100 points.

Band is a performance-oriented activity and a performance situation cannot be recreated.

*If a student misses a performance because of an **excused** absence, he/she will be allowed to write a paper to make up the points missed.

NOTE: H.O.T. (Homework On Time) sheets will be given to any student not turning in their practice journal or not completing a test on time. Students will be expected to make up this assignment and get it turned in **1 week prior** to the end of the quarter or semester. If the student returns the H.O.T. sheet and assignment (s) by the deadline, they will be given half credit.

E. EXTRA CREDIT

Students can receive extra credit for activities music related and completed outside of scheduled rehearsal times. Examples of extra effort credit include, but are not limited to: attending/performing in a music concert and writing a performance review, auditioning for an honor group, participating in a small, ensemble, writing a research paper on an approved music related topic. All extra effort opportunities must be pre-approved by the directors. Please check the calendar to see what events might qualify for extra effort credit.

To receive credit, all performance reviews must be submitted no later than one week after the performance.

PLEASE NOTE: Dismissal/Student Pick Up

As a staff we always want to be respectful of the time that is given to the band program. For that reason our rehearsals will be dismissed on time. Students will still need to put their equipment away etc but instruction and announcements will be completed by the scheduled time. Performance ending times are always a bit more difficult to estimate cell phones are a valuable tool towards communicating return times. And as the staff strives for courtesy of ending times for band events, we respectfully ask that parents and students do the same for the staff. Students are expected to be picked up no later than 20 minutes after dismissal of rehearsals or arrival from a band event. Please have back up arrangements in case you are not able to promptly pick up your student. We are asking for your assistance in this matter as it has been a problem in the past.

IV. Trips

- A. Students are expected to abide by all conduct rules as set forth by the school district and the teacher. Disregard of these rules will be dealt with severely. You represent your school, parents and community. Negative behavior will not be tolerated.

V. Equipment

- A. Students using school equipment must follow the contract guidelines that they entered into with the school district on the instrument/equipment agreement form. There is a yearly \$40 usage fee which will provide the student an available school instrument in working condition. It should be noted that the student is responsible for repairs to the instrument during the school year.
- B. Personal instruments may not be left at the school overnight. **They are not insured by the school district.**
- C. Students are charged with the responsibility of keeping the room clean and in order. **There is to be no food, gum or drinks in the room,** in accordance with the Nixa Junior High school rules.
